



ClubSwan Rules & Regulations

ART. 1 THE MISSION

ClubSwan appreciates and treasures the passion and the respect for nature and sport, and values beauty, elegance, freedom and challenges.

ClubSwan develops the passion and the enjoyment Swans bring to their owners, close friends and those supporting the ongoing Swan legend by promoting the spirit of Swan.

ClubSwan intends to be a reference point for all its Members—offering events, qualified services and outstanding opportunities while increasing the occasions for meetings and exchanges amongst Members.

ART. 2 THE CLUBHOUSE

The Clubhouse is located at the Yacht Club Segelsällskapet in Pietarsaari, Finland.

The Members may use the Clubhouse and take part in the activities of the Yacht Club Segelsällskapet according to the regulations of its charter.

ART. 3 CHAIR & CLUB ADMINISTRATION

ClubSwan is a non-profit organization, of unlimited duration.

The Chairman of Nautor Holding shall be the Chairman of ClubSwan.

The ClubSwan Chairman shall elect the members of the Governing Board from among the Members of ClubSwan.

The Governing Board shall consist of a maximum of six members including Members of the Board of Nautor Holding, Full Members and Honorary Members.

The Chairman shall hold the deciding vote.

The Governing Board shall set the rules and regulations for ClubSwan.

ART. 4 MEMBERSHIP

There are three Membership categories: Honorary Members, Full Members and Guest Members.

HONORARY MEMBER

Honorary Members may be invited to join ClubSwan by the Governing Board, chosen from among outstanding personalities of the international sailing world and those who continue to support the legend and the yachting values of Swan all over the world as well as develop the mission of ClubSwan.

FULL MEMBER

The owner of a Swan yacht, from the moment of its acquisition and throughout the whole period of ownership, shall be a Full Member.

The spouse of an owner and all children over 18 years of age are entitled to Full ClubSwan membership.

GUEST MEMBER

Full Members will remain as Guest Members of ClubSwan after the sale of their Swan by contacting the ClubSwan Manager.

Full Members, Honorary Members and the Governing Board may introduce new Guest Members.

Full Members wishing to introduce Guest Members must forward the request to the ClubSwan Manager. Full Members may request the introduction of two guest members per year.

ART. 5 CLUBSWAN MEMBERSHIP CARD

Each ClubSwan Member shall receive a membership card enabling him or her to gain access to dedicated ClubSwan services, products and privileges.

The Full Member's Card is valid for the entire duration of the ownership. The Honorary Member's Card is for life. Guest membership is valid for two years, and can be renewed upon expiration by contacting the ClubSwan Manager.

The loss of a Membership Card must be communicated in writing to the ClubSwan Manager at clubswan@nautorswan.com in order to arrange for its replacement.

ART. 6 CLUBSWAN MANAGER

ClubSwan has a dedicated Manager to assist Members with their requests for information and to handle the administration and coordination of the Club's activities. The ClubSwan Manager directs and supports Members for all the service assistance and customer care information and is situated in the Nautor's Swan headquarters in Florence.

ART. 7 AIMS & ACTIVITIES

ClubSwan intends to fulfill the mission and generate benefits for its Members, identifying outstanding opportunities, facilitating the access and availability of qualified services, promoting and supporting events, activities and occasions for meeting. This includes privileges, access and invitations to selected boat shows, yachting related events and sea trials.

1. ClubSwan organizes and promotes Swan related racing events. It supplies information about all the international sailing circuits and provides advice to ClubSwan Members taking part in its activities.
2. Reciprocal Programs: ClubSwan is aligned with some of the most prominent Yacht Clubs and institutions around the world with whom Reciprocal Agreements are in place for the exchange of hospitality, activities and privileges.
3. Privilege hospitality at selected marinas: Some of the best marinas around the world offer special benefits to ClubSwan Members.
4. ClubSwan will be present at all ClubSwan regattas to offer assistance and information to Members.
5. Participating in some of the activities and services of ClubSwan may involve the payment of a fee by the Member.

ART. 8 COMMUNICATION & CONTACT INFORMATION

ClubSwan periodically publishes the ClubSwan Magazine and ClubSwan Directory as well as other email communications.

All official communications shall be located in the ClubSwan section of the Nautor's Swan website.

Members are kindly asked to inform ClubSwan of any change of contact information.

ART. 9 LOSS OF MEMBERSHIP STATUS
